STATEMENT OF EXEMPT PURPOSE

The Franciscan Foundation for the Holy Land was established to safeguard human rights and continued presence of the Christian minority in the Holy Land. The Foundation provides the Christians in the Holy Land with housing, college scholarships, tuition and books for school age children and other humanitarian support.

STATEMENT OF PROGRAM SERVICE ACCOMPLISHMENTS

The three largest and most successful programs that the Franciscan Foundation has achieved are as follows:

4a. College Scholarship Program

One of the principal solutions in helping to stem the Christian exodus from the Holy Land and more specifically, from Israel has been through providing a college education for those Christian students who have met following conditions:

- a. They must be economically marginalized
- b. They must maintain a B average throughout high school

These scholarship grants are available to any Christian student from any Christian denomination wishing to apply for a four year college program. The winners of the scholarship grants are chosen by the FFHL Scholarship Board made up of four professors residing in the U.S.

Each student selected must first show a letter of acceptance from the university that they are planning to attend and once that is validated, they can begin their studies in the fall and payment for their school tuition commences.

Since 1997, FFHL has provided \$3,400,000 for these scholarship grants.

Results:

1. *As of 1997, FFHL has given 178 scholarship grants.*
2. *As of 2011, 91 students have successfully graduated from the various universities.*
3. *Presently 78 students are attending college.*
4. *Out of the 91 students who have graduated:*
 - *75% are now professionally employed,*
 - *27 % decided to get married,*
 - *2% dropped out of the university.*

Of the 75% who are now employed in the Holy Land....they have decided to remain in the Holy Land thus achieving the goal of FFHL.

4b. Housing

The second successful program has been in the area of housing. This is an area that is constantly evolving and because our approach of stemming the Christian exodus, our priorities have been first to provide a college education, then secondly, to assist them in finding employment and thirdly to assist them in housing.

Because of high priority of a college education, we only began assisting the Franciscan Custody by providing supplemental funding for housing beginning in 2001. *Since that time we have provided apartments for some 19 Christian families in Bethlehem at a cost of \$1,733,400.00* Because of the high construction costs each two bedroom apartment cost \$90,000.00 to build. We also are aware of the great economic crisis facing our people in Bethlehem and hence the rent for each family unit is only \$250.00 per month.

4c. Sponsor a Child Program

Our third successful program has been in "Sponsoring a Child" program where we find sponsors in the US to financially assist, for a period of seven years, those children attending school whose families are not able to pay for their yearly tuition of \$500.00 due to economic difficulties. FFHL believes that every child should have an opportunity to an education and no one should be turned away from attending class.

Our program for Child Sponsorships is a seven year commitment beginning from the 6th grade to the 12th grade. At present we have over 230 economically marginalized children attending classes in Jerusalem, Jaffa, and Bethlehem who would otherwise not be receiving an education.

Since 2004, we have provided \$905,000.00 in funding for their education.

Total Program Services Expenses: \$1,684,011

The amount of grants awarded is controlled ultimately at the headquarters of FFHL in Washington DC. They maintain accurate and computerized records of all funding going to the Custodia di Terra Santa, a Roman Catholic religious institute, via the Franciscan Foundation for the Holy Land, (FFHL) which is a religious arm of the Custodia di Terra Santa. FFHL has specific humanitarian programs and projects to provide economic assistance in the form of education, housing and aid for Christians in Israel or the Holy Land.

All funding coming to the Holy Land is monitored by FFHL. For example in the "College Scholarship Grants" selection criteria for candidates applying to receive a free four year college scholarship must meet the following requirements:

1. The candidate must maintain a B average throughout the four years of high school.
2. The candidate must be a Christian.
3. Only one sibling may apply per family for a scholarship grant.
4. Scholarship grants can only be given to those beginning the first year of college through the last year of college.
5. The family must be economically marginalized.
6. All of our students must attend college in the country of Israel, Jordan or Egypt.

College scholarships are not given to students wishing to study outside of these geographical areas.

Applications are given out to Christian schools in the country and anyone can apply. After all the applications are in together with their high school transcripts, they are sent to four teachers or professors, along with the President of FFHL, who make the final decision of who will or will not be receiving a college grant. If for some reason, a candidate has been chosen and is unable to get into a college, a list of approved students in the second level of choice will be given the opportunity.

General Funding for College Scholarships run between \$3,000- \$6,000 per year per student or between \$12,000 - \$24,000 for four years of college. FFHL maintains accurate computerized records on what was spent on each student per year for tuition and books and recorded. Funding is transferred each fall semester for four years to the particular college that the student is attending and receipts are kept from the colleges receiving the funding.

Another program is the "Franciscan Boys Home" for boy's ages 7-13 years of age, who come from dysfunctional families residing in Bethlehem and to assist them psychologically and emotionally. They stay at the 'home' six days a weeks and return to their families on Sundays. FBH provides professional staff of teachers and child

psychologists to assist these children. A proposed budget is prepared every year for the various expenses incurred by this home and must be approved by FFHL board of trustees in the US and is monitored by FFHL in Israel.

Any of the remaining programs of FFHL are followed in the same way. Computerized records are kept by FFHL.
